Bookings	To secure your wedding date, a non-refundable 50% deposit is required, which will be deducted from your final total.
	This fee must be paid within 48 hours of your initial inquiry; otherwise, the date will be released to other clients. For details on amendments or cancellations, please refer to our cancellation policy.
	Changing your booking date incurs a £100 fee. If Aimee is unavailable on the new date, any deposits for the original date will be retained.
	The minimum spend for wedding day bookings (Including Bride only) is £500, excluding travel expenses and previous trials.
Deposits	A non-refundable deposit of £100 is required in advance to secure any service. Without this deposit, the booking cannot be confirmed. The deposit will be applied to the final event cost. Please note that scheduling a trial without paying the deposit does not guarantee your booking.
Cancellation	Between Booking Date and 6 Months Before Wedding: If you cancel during this period, no additional charges will apply, but any deposits paid will be retained.
	Within 3 Months of the Wedding Date: Cancelling within this time will incur a charge of 50% of the total quoted amount and deposits paid will be retained
	Within I Month of the Wedding Date: Cancelling within this period will incur a charge of 100% of the quoted balance and deposits paid will be retained.
	Changes to Wedding Day Services: Once your wedding date is confirmed with a £200 retainer fee, the quoted price will be fixed. If services are later reduced, the original quote must still be paid.
	Unexpected Unavailability of Artist: If Aimee is unable to provide services on your trial or wedding day due to reasons like illness, accident, or weather, reasonable accommodations will be made, including a full refund for services not provided.
	Efforts will be made to arrange a replacement artist if possible, but availability cannot be guaranteed.
Travel	A mileage fee of £0.50 per mile will be charged from SE22 to your location. This will be calculated and confirmed when discussing your quote.
	Additional costs may apply, including (but not limited to) airfare, hotel accommodations, transportation, congestion charges, tolls, and parking
	An early fee booking of £50 will be charged for bookings and/or travel that start before 8 am.
Liability	All brushes, tools, and makeup products are sanitized between each application.
	Clients must inform Aimee of any skin conditions or allergies before application. If needed, a sample test can be done to check for reactions.
	By booking, clients agree to release Aimee from liability for any allergic reactions
Setting up &	Aimee will arrive at the location at the time pre-agreed with the bride, usually 30 minutes before start time to allow sufficient time for setting up.
Timings	In the run-up to your wedding day, you will receive a proposed schedule for the morning, including timings for each person having their make-up done. This ensures a smooth, enjoyable experience for everyone on the day.
	Aimee is not exclusively available for the entire day of the event. If you request additional services for your day, such as touch-ups or a change, an exclusivity fee will apply.
	A set-up work surface or table will be required for Aimee to sufficiently set up her kit; please bear in mind light where possible and a chair/stool to sit on whilst you're having your make-up done.
